*If mailing a check please, make sure to call us in advance so we can pencil you in. We allow 7 days for the deposit to arrive. If the deposit has not been received in 7 days you will be removed from the spot being reserved in your name without notice.

All deposits are non-refundable and non-transferrable to any other person(s) or for other goods and services. No exceptions. Your deposit is to hold your pick number in line for the litter named above. All deposits are applied to the total cost of the puppy.

It is the sole responsibility of the adopter to keep Windmere Kennels updated with any change in contact information such as address, phone and email.

Your deposit is valid for 1 year from the date it was placed. Changes to litter, sex, size and/or color are only allowed until a puppy has either been chosen or accepted by the adopter. Once a puppy has been chosen or accepted changes of any kind are no longer accepted. If changes are made, final cost of puppy may change as our puppies do vary in cost depending on size, color, markings and breed. We never guarantee size or color as we are at the mercy of Mother-Nature and have no control over those things. We can only make educated predictions.

If for any reason a puppy is not available to you from the litter for which the deposit was placed, we will offer you another puppy from another litter if one is available. Or we may place you on our next available litter fitting your size and color preferences. A puppy must be chosen or accepted within the 1 year allowed or the deposit is forfeited. Prices may vary depending on what changes have been made.

Windmere Kennels reserves the right to refuse to sell a puppy to anyone, at any time, for any reason. These are our babies and they deserve only the best.

Windmere Kennels reserves the right to change our deposit amount and/or adoption cost of our puppies at any time without notice. We will honor the price on the original receipt if no changes have been made.

When puppies are born, Windmere Kennels will call the phone number listed on the deposit agreement within 48-72 hours. We will also tell you your litters pick up day or start of Pre-School/Prep-School. If no one is available, we will leave a message if it is an option or notify you through Facebook Messenger. Pictures or videos of your litter will be updated on our Facebook page within the same timeframe and then at a minimum of a bi-weekly basis.

When puppies are 5-6 weeks of age, we will begin the choosing process. If for whatever reason you are unable to meet with us within that 5-6 weeks of age time frame, you may forfeit your pick number in line so that we are able to maintain a level of fairness to those families behind you in the picking order. If you are at or near the top of the picking order expect to be asked to meet with us closer to the 5 weeks of age time frame. Also, we are not typically available for weekend appointments. Be prepared to accommodate a Monday through Friday, 9am to 5pm appointment. Being

unable to do so may result in the forfeiture of your pick in line. We offer Facetime to all our families.

A designated pick up day for your puppy will be at approximately 8 weeks of age and is pre-determined by the breeder. Or, your puppy can enter our Puppy Pre-School/ Prep-School program on the Friday nearest the 8-week birthday and ends on the final Friday of classes. Puppy Pre-School is in addition to the price of the puppy. ALL PUPPIES MUST BE PAID IN FULL AT 6 WEEKS OF AGE. Failure to do so or to neglect to notify us of when payment will be made within an acceptable time frame may result in us finding an adoptive family for your puppy and the forfeiture of your deposit. Every puppy deserves to have a family who will love them when they're ready to go home and we are simply unable to risk that not happening. You may make final payment by personal check, cashier's check, money order, debit or credit card. There are no exceptions made. Training fees are due in cash either at the time of pick up or per the payment schedule listed in the Pre-School/ Prep-School pamphlet(s). Once the puppy has been paid in full there are no refunds of any kind. If an adopter is unable to follow through with the purchase of their puppy, we will roll the payment over, minus the deposit to another puppy and allow 1 year for those funds to be used from the date of the original deposit. We will be unable to guarantee adoption cost, color, sex or size in these situations. If there are additional adoption costs, they must be paid at the time the puppy is chosen or accepted. We rely on our families to have thought through the decision to add a forever family member to their lives and have zero tolerance for those adopting a puppy on a whim.

If you are unable to pick your puppy up on the designated pick up day, there will be an additional cost of \$50 per day due at pick up until the puppy is able to go home with you. This will also include the day of pick up. Go home appointments are typically Monday through Friday from 9am to 5pm and we ask that you be prepared to accommodate this schedule.

All payments made by credit or debit card are charged an additional 3.99% convenience charge by our processing company.
